Dr. J.P. Knight, all of my one-half interest in all of two certain tracts of land described as follows, to-wit: One tract containing fifty-four and three-fourths (54-3/4) acres, more or less, situate in Dunklin Township, State and County aforesaid. Beginning at a stone X S. 7 E. 31-40 stone, S. 78 E. 15-00 stone x, S. 19 E. 6-10 stake 3x, S. 64 W. 8-40 stake x, N. 86 W. 7-50 B. 0. X, N. 54 W. 25-50 stake X in road; thence along road N. 34 E. 7-67 stake x, N. 26 E. 21-13 P. 0. x, N. 40 E. 3-07 beginning.

Also all of Thirty-two and one-half (32-1/2) acres, more or less. Being a portion of the Harry Gantrell tract. The said Dr. J.P. Knight already had one-half interest in these two tracts.
