(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Arizona G. Mahaffey and J.N. Finley, all that certain piece, parcel and tract of land situate, lying and being in the State and County aforesaid, about One mile North of the town of Greer, adjoining lands of G.W. Center, myself and others, and being a part of the same land conveyed to me by deed from Arizona G. Mahaffey and E.D. Green, said deed bearing date of Jan. 27th, 1920 and recorded in the office of the P.F.C. for Greenville County in Book 71, page 302, and having the following courses and distances:
Beginning at an iron pin in the center of the Slaughter Pen Road, said pin being Six and eight-tenths (6.8) feet from the iron pin corner of tract conveyed by me to Arizona G. Mahaffey and J.N. Finley, Feb. 1st, 1925, and runs thence with the said road S. 23-54 W. 79 feet to a bend in said road; thence with said road S. 53-45 W. 740 feet to a bend in said road; thence with the said road S. 75-00 W. 31 feet to an iron pin in the center of the said road; thence N. 5-00 E. 364 feet to an iron pin on east bank of large gully; thence N. 15-45 E. 296 feet to an iron pin by gate post near a large poplar; thence N. 76-30 E. 85 feet to an iron pin by a sourwood post near branch; thence N. 29-30 E. 157.5 feet to Sycamore tree on bank of branch thence up a gully S. 45-35 E. 390.7 feet to a black oak on east bank of gully; thence S. 73-45 E. 141.4 feet to the beginning corner, containing Six and three one-hundredths (6.03) acres, more or less.
