the receipt whereof is hereby acknowledged. have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said C. F. Putnam, All that certain parcel and lot of land situate and being in said State and County, Greenville Township, in City View and designated as Lot No. 5 as shown by a plat recorded in Plat Book A, at page 327, office of R. I. C. in and for Greenville County, said lot having a frontage of fifty (50) feet on V. I. C. A. Street, and running back, side-lines parallel, a depth of one hundred (100) sixty feet and being the same lot of land conveyed to W. R. Cason by E. C. Stephens by deed recorded in Vol. 73, at page 2, and being one of the lots conveyed to us by W. R. Cason by deed recorded in Vol. 105, page 109 in office of R. I. C. in and for Greenville County. It is understood and agreed, and it is a part of the consideration of this conveyance, that the grantee herein does hereby assume and agree to pay a balance of One thousand (\$1000.00) Dollars on a certain mortgage given by E.
