Tract #1 - Containing five (5) acres, more or less, being a portion of tract #3 of the J. D. Bridgers property, as shown on plat made by R. E. Walton October 1919, which plat is recorded in R. M. C. office for Greenville County in Book 80 at page 170, being the same tract of land conveyed to J. D. Rainey by J. D. Bridgers by deed dated 20th of August, 1920, recorded in said office in Vol. 69 at page 96, reference being made to said deed for a full description by metes and bounds.

Tract #2 - Containing five and three one-hundredths (5.03) acres, more or less, being known and designated on said plat of R. E. Walton dated October 1919, as Tract #4, and being the same tract of land conveyed to J. D. Rainey by W. J.
