(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Annie S. Tillman and A. L. Lewis; -
To Annie S. Tillman a three-fourths (3/4) undivided interest,
and to A. L. Lewis a one-fourth (1/4) undivided interest in all
that certain lot or parcel of land, situate, lying and being
in Greenville Township, Greenville County, State of South Caro-
lina, near the City of Greenville, on Jones Avenue, known and
designated as Lot No. 5, according to a plat of the property of
W. C. Daniel, which plat is recorded in Plat Book "F", at
Page 186, and having, according to said plat the following
notes and bounds, to-wit: -

Beginning at an iron pin on the East side of Jones Ave-
nue, joint corner of Lots Nos. 4 and 5, and running thence
with the joint line of said lots S. 89 E. 190.2 feet to an iron
pin in line of Donaldson property; thence with the line
of said property S. 1-01 E. 76.05 feet to an iron pin; thence
of Lot No. 6; thence with the line of said lot N. 89 E. 192.27
feet to an iron pin on the East side of Jones Avenue;
thence with said Avenue N. 1-00 E. 70 feet to the point of
