(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Greenville Realty & Investment Co.,  
all that certain piece parcel, or lot of land in  
the City of Greenville County and State aforesaid  
on the Southeast Corner of Frank Street and  
Hampton Avenue;

Beginning at a stake on the east side of  
Hampton Avenue and the south side of  
Frank Street, at the corner of said street, and  
running thence N. 32-40 E. with Hampton Ave  
45 feet to a stake; thence N. 57 E. 100 ft to  
a stake; thence N. 32-40 W. 45 feet to a  
line parallel with Hampton Avenue to a stake  
on Frank Street; thence with Frank Street  
57 W. 100 feet to the beginning corner, said being
