designated as Lot No. (4) Four, of Block (1) One, accord-  
ing to that thereof recorded in the C. M. C. Office for  
Greenville County, in Plat Book H, Pages 21 to 24, re-  
ference being made to said plat for a more complete  
description of said lot.  
In executing this deed, the Grantor herein agrees that  
the covenants, restrictions, shall act as covenants  
running with the land, and that in event of viola-  
tion of any of them, the property herein conveyed  
shall revert to the immediate grantor;  
The Grantor herein binds herself, her heirs and  
assigns, never to publicly advertise for sale any  
lot or lots in this subdivision at a price less  
than that at which the Etowah Realty Corpora-  
tion is advertising similar lots in said Car-  
olanda Estates;  
(2) No lot in this subdivision shall be sold, lease-  
d, or rented in any manner, directly or in-  
directly, by any title, either legal or equitable,  
to any person not of the Caucasian race, nor  
to any corporation of which any stockholder  
shall be other than of the Caucasian race;  
(3) No nuisance shall be permitted to be maintain-  
ed on any lot in this subdivision.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said
