Finlay:— All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, at the Southeast corner of the intersection of McDaniel and Crescent Avenues, and having, according to a plat recorded in the R.M.C. Office for Greenville County, in Plat-Book "G" at page 20, the following metes and bounds, to-wit:—
