with, assigns forever, the fourth (1/4) interest in the

A certain parcel or tract of land known as tract
No. 1, and embracing the homestead of Dr. J. M. Miller
deceased, being, lying and situate in the state and
county aforesaid, on Horse Creek, waters of Riedy
Creek, Franklin Township, containing .278 acres
More, or less, and, having the following marks, metes
