Shoals Road, at a point where it adjoins and
intersects another road, and running thence along
the said Fork Shoals Road, N 59 $\frac{1}{4}$ E. 8.85 to stone, thence
S. 80.8 E. 15.0 to iron pin, thence due S. 7.50 to iron
pin; thence S. 82 $\frac{1}{4}$ E. 2.50 to iron pin; thence N. 47 $\frac{1}{4}$ E.
