Mary Ellen Ross, her heirs and assigns forever:
all that certain piece, parcel or tract of land situate, lying and being in the County and State aforesaid, and beginning at a point on the Fork Shoals Road, at a point where it adjoins and intersects another road, and running thence along the said Fork Shoals Road, N 59 1/4 E. 8.85 to stone, thence S 80.8 E. 1.50 to iron pin; thence due S. 7.50 to iron pin; thence S 82 3/4 E. 2.50 to iron pin; thence N. 47 1/2 E. 6.55 to iron pin; thence S. 55 E. 23.50 to iron pins, thence S 26.35 E. 2.32 to corner on branch, thence along the branch as a line N 76 1/2 W. 9.15 to corner, thence N 89 W. 2.25 to a stone in road; thence along said road S 19.17 to the beginning, containing 25 acres, more or less.
