EXTENS OF LEASE.

Agreement, made this 17th day of August in the year 1931, by and between Hampton Merc. Co., J. J. McEbee, (Piedmont, S. C.,) hereinafter called "IESSOR", and Standard Oil Company of New Jersey, a corporation of the State of Dolaware, hereinafter

Whereas, on the 19th day of September in the year 1930, the parties hereto entered into a certain lease recorded on the 50th day of October in the year 1930, in the office of the R. M. C. of Greenville County, in Book 101, at page 518, wherein the Lessor demised unto the Lessee for the period of one year beginning on the 1st day of October 1930, and ending on the 50th day of September 1931, the premises described in said lease.

Whereas, the parties desire to extend or renew the period for which said premises were demised;

Now, Therefore, In consideration of the mutualities hereof, It, is agreed:

- 1. That the premises described in said lease herein mentioned are hereby demised unto the Lessee for the term of one year beginning on the 1st day of Ootober 1931, and ending on the 30th day of September 1932.
- 2. Lessee is to pay therefor the rental specified in the hereinbefore described lease at the times and under the conditions therein described.
