Let on Runcombe Street, City of Greenville, see Deed Book 45, page 531, for full description conveyed to E. M. Wharton by the late J. F. Hunt; this is known as Wharton Apartments.

Let at corner of E. North Street and Lavinia Avenue, see Deed Book 53, page 380, conveyed to E. M. Wharton by Florence R. Brinkshank for full description; this is known as Maryland Apartments, said City.

Let on Hampton Avenue, City of Greenville, see Deed Book 143 at page 349, conveyed to E. M. Wharton by Lyda Ward.

Let on 11 Section "A", Paris Mountain, base and Head Co. on Sasser Head. See Deed Book 132, at page 32.
