any sort, kind or description of improvement,  
addition, attachment or device that the said  
Greenville Textile Supply Company may see fit  
to manufacture, attach and sell all such  
improvements, attachments, devices, additions,  
accessories, etc. to be and remain forever the  
property of the said Greenville Textile Supply Co.  
its successors and assigns; and any im-  
provement, addition, attachment, device, accessory,  
etc. that may hereafter be made or hereafter  
patented by the said Stairley, his successors  
and assigns, for use in connection with the  
said patent herein referred to, so which could  
be used, in the opinion of the Greenville Supply  
Company, its agents and representatives, and  
in connection with the patent herein referred to,  
shall be and forever remain the property  
of the said Greenville Textile Supply Company,  
its successors and assigns.

It is further agreed that said Greenville  
Textile Supply Company will have an audit  
made annually of all of its transactions  
with reference to the manufacture, sale, royalty,  
etc. of said article, articles, improvements,  
attachments, etc. showing in full the number  
prices, etc. of the articles manufactured and of  
the articles sold and of the royalties due  
therefrom and how much of them paid,  
said audit to be made by some one to be  
approved by the said Stairley.

It is further agreed that the said  
Greenville Textile Supply Company will at all  
times exert its best efforts in marketing  
said articles, to advance the use of and  
inance the interest in the use and  
consumption of same.
