Rainey, at a point about 400 feet south of present line of the Postal Telegraph Company, and run eastward approximately parallel to said line of Postal Telegraph Company to the road leading from Taylors to Brassey Creek Church, thence southward down said road until leaving the above named property. It is further understood that the Southern Public Utilities Company agree not to destroy any crops or buildings by reason of the construction, inspection, maintenance, and operation of said line.
