the said piece, parcel or lot of land in
Greenville (City No. 1), Greenville County, State of
South Carolina, and Central Avenue, in Ward Three
of City of Greenville, known as part of lot No. 3
of plat recorded by C. M. Farnam in Book 105
of Lots & Pages, page 205, having the following metes
and bounds: Beginning at the peach tree of
Central Avenue, 100 feet from the corner of Central
& Street and Central Avenue and extending along
said Central Avenue in an easterly direction of
57 feet, thence to a stake, corner of lot No. 4
and said plat, thence along line of lot No. 4
168 feet, thence to iron post corner of lot
of C. M. Farnam, thence along line of lot of Farnam
