All my right, title and interest in and to the following described real estate, the same being a one-fifth undivided interest:

All those lots of land in Greenville Township, Greenville County, S.C., just outside the City limits of Greenville, and being known as: Lots 6, 1, 8, 86 and 87 as shown on plat of subdivision known as Woodside Circle, plat recorded in R.M.C. Office in Plat Book "E," page 219; lots 6, 7 and 8 having a frontage of 25 feet each on Rutherford Road with a depth in parallel lines of 150 feet; lots 86 and 87 having a frontage of 25 feet on S. Woodside Circle; lot No. 86 being 170 feet deep on the side and 165 feet on the other; and lot No. 87 being 165 feet deep on one side and 157 feet on the other.
