(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

W. R. Simmons, his heirs and assigns:

All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in a sub-division known as Park Place, having a frontage on the north side of First Avenue of fifty feet, and running in depth along parallel lines one hundred fifty feet to an alley, being shown as lot no. 5 on plat of said sub-division recorded in Plat Book A, page 119. There is situated on this lot a one-story frame dwelling. On this lot there is a mortgage of One Thousand Dollars bearing interest at eight percent, payable annually, executed in favor of M. A. Wallace and recorded in Vol. 202, page 46.

Also all that certain lot of land in the County and State aforesaid, near the City of Greenville in a sub-division known as Park Place, fronting fifty feet on north side of Second Avenue, running in depth along parallel lines one hundred fifty feet to an alley, being shown on plat of said subdivision as Lot 14, Block A, said plat recorded Vol. A, page 119.

Also, all that portion of a lot adjoining the lot last above described herein, said parcel being the rear part of Lot no. 12 as shown on some plat of Lots 5 and 14 herein above described, and being fifty feet in width along some alley lying in rear of Lot 14 and having a depth of forty feet. On the lot two lots herein above described (Lot 14 and part of Lot 12) there is a mortgage of \$4000 executed in favor of H. P. McKee, recorded in Vol. 196, page 144, bearing interest at eight percent, payable annually.

Also all that lot of land in the County and State aforesaid in a subdivision known as Park Place, fronting fifty feet on north side of Second Avenue, running in depth along parallel lines one hundred fifty feet to an alley, shown as Lot 16, Block A, of some plat above referred to, having situated thereon a six-room frame dwelling and covering on this lot there is a mortgage of One Thousand Dollars executed in favor of Carabin Loan & Trust Co., dated April 2, 1928, recorded in Vol. 186, page 154.

The grantee herein becomes and agrees to pay the three mortgages hereinabove described, together with interest accruing from date of this conveyance
