All that certain piece, parcel or lot of land situate,
lying and being in the City and County of Greenville,
State of South Carolina on the east side of James
Avenue, known and designated as Lot No. 10, corner plot
of the property of J. Helle McDaniel according tax plan
recorded in the Office of Assessor, Greenville County, S. C.
in Plat Book 1, page 102 and having according
to said plan the following lines and boundaries to
wit:

Beginning at a point on the last side of James
Avenue, at corner of Lot No. 10, 70 feet from the
west line of Lot No. 10, 70 ft. 8-1/2 ft. 149.8 feet to a point
thence N. 12° 46' 55.1 feet to a point on a proposed street
to be named as Second Avenue Extension, thence with
said proposed street S. 29° 21' W. 150.1 feet to a point on
James Ave., thence with James Ave. S. 1.182 W. 68.9 feet
to the beginning corner bearing the same lot of land
conveyed to me by J. Helle McDaniel by deed recorded
in Plat 117 at page 252.

2. That no building shall be erected upon said
lot nearer than thirty five feet of the sidewalk on
James Avenue.

3. That no building other than an outhouse
shall be erected upon said lot casting less
than the sum of \$100.00.

4. That said lot shall not be used for any
purpose except residential purposes.
