being about three miles north of the city of Greenville and being known as lot No. 223 of a tract of land known as Colonial Company Tract, and having the following metes and bounds, to wit: Beginning on the west side of North Franklin Road, at an iron pin, point corner of late Nos. 222 and 223, thence which point line of late Nos. 222 and 223, N. 57° 32' W. 204 feet to an iron pin, point corner late Nos. 222 and 223; thence S. 37° 58' W. 65 feet to an iron pin just corner late Nos. 222 and 221; thence with said line of late Nos. 222 and 221, S. 57° 32' E. 200 feet to an iron pin, point corner late Nos. 222 and 221, and also being on the west side of North Franklin Road, the free with the West side of North Franklin Road, N. 57° 32' E. 65 feet to an iron pin, point corner late Nos. 222 and 223, and thence also the beginning corner, as shown by plan made by Surveyor and Engineer, 1929.
