In the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release

unto the said John Preston Batson,

all that place, parcel or lot of land in Greenville

Township, Greenville County, State of South Carolina

In Ward 2 of the City of Greenville and having  
an easterly width of thirty and four rods, bounded to west  
beginning at stake on the west side of Railroad  
Street and running thence along said street S.  
12° 55' 30" feet to a stake, thence N. 77° 30' 24" 60 feet to a  
stake, thence N. 12° 55' 6.30 feet to a stake thence S.  
77° 30' 6.46 feet to the beginning corner and being known  
as lot 18 on a plat of Thiesen, Hogan and Broseley's  
subdivision of Pickland Creek, lands surveyed  
July 1911 by J. C. Wilson, Eng., and being the same  
lot of land conveyed to me by the City of Greenville  
Also lot no 56 having the following corners  
and boundaries to west:

Beginning at a run on the east side of Center  
Street and running thence S. 15° 34.30 feet to a stake,  
thence S. 77° 30' 6.30 feet to a stake, thence N. 12° 50' E.  
30 feet to a stake, thence N. 77° 30' 24.54-07 feet to the  
beginning corner.

Also all that place, parcel or lot of land in  
the City of Greenville, Ward 2, State of South Carolina  
and in the County of Greenville and having a  
frontage of thirty (30) feet and a depth of fifty  
feet, the same being lot no 51, fronting on  
Center Street, on Plat made by P. E. Battson, July 1911,

a part of the tract bought by Heagans and Broseley  
of L. A. Muller, deed January 28th, 1911, and recorded  
in Volume 16, page 13, R. M. C. Office for Greenville
