Know all men by these presents that Southern Guaranty and Trust Company (successor to Title Guarantee and Trust Company), a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville, in the State of South Carolina, as Trustee, for and in consideration of the sum of one dollar to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto William R. Timmons all those certain lots, pieces or parcels of land situate, lying and being in the State of South Carolina and County of Greenville, just north of the corporate limits of the City of Greenville, being portions of the "North Hills" property and being known and designated on certain plats of said property recorded in the office of the Register of Mesne Conveyances for said County and State as follows: to wit:

This is a portion of the land conveyed to said grantor, as Trustee, by B. E. Geer and others, by deed dated January 25, 1925, and recorded in said office in Deed Book 100, at page 423; these presents being executed in accordance with the terms of said trust deed. This is not a sale but a reconveyance to the beneficial owner, who is paying no money for this transfer.

This property is conveyed subject to the lien of a mortgage (originally for \$35,000.00) given to Galloway Building Company by said B. E. Geer and others, dated January 15, 1925, and recorded in said office in Mortgage Book 156, at page 21. It is stated to this grantor by the beneficial owners of said "North Hills" property that the said William R. Timmons is entitled to a one-quarter (1/4) interest in said property, and is liable for the payment of twenty five per cent. (25%) of the balance due on said mortgage, \$13,811.63, with interest from July 15, 1930.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee hereinabove named, and his heirs and assigns forever.
