Having the following Miles and Hours: Beginning at an open gap in settlement road and running thence S. 14° 57' 8" E. 1.45 to stone; thence S. 75° 44' 20.11.15 to stone 0 m; thence S. 52° 6.20.53 to stone 0 m; thence N. 26° 4.11 to stone 0 m; thence N. 71° 45' E. 11.21 to stone 70 m; thence N. 2 W. 6.66 to settlement road; thence with settlement road N. 66 W. 2.73 to head; thence S. 74 W. 5.63 to head; thence N. 89 W. 3.83 to head; thence N. 45 W. 2.00 to head; thence N. 79 W. 3.18 to beginning corner containing 24 1/4 acres, more or less, bounded by lands of C. M. Bishop, Jr., Mr. & Mrs. J. L. McCauley and others, being the same conveyed to P. D. Sutton by R. C. Benson by deed dated October 14, 1924, recorded in book 96, page 138.
