2.92 to a stone 3x0, thence N. 82 W. 6.00 to a B. C.
3x0; thence 46 $\frac{1}{4}$ W. 9.57 to a Dogwood 3x0; thence N.
67 W. 4.00 to a Chestnut tree 3x0; thence S. 47 $\frac{1}{4}$ W.
5.40 to a stone 3x0; thence S. 7.9 W. 4.30 to a stone
3x0 in the branch; thence up said branch 7.07 to
stable in creek or branch; thence S. 69 $\frac{1}{4}$ W. 8.2 Link
to a Locust Post; thence S. 4 W. 14.75 to a stone 3x0;
thence to a stake 3x on the Buncombe Road, on old
line; thence along said road as a line to the
