in the State aforesaid, the receipt whereof is hereby acknowledged, have granted bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said *J. C. Upton* *Gallaville* Township, Greenville County, State of South Carolina,

and being known and designated as Lot No. 18 according to plat of property of *W. C. McDaniel* recorded in *R. M. C. Office for Greenville County in Plat Book "A" at page 102* and having the following metes and bounds, to wit: Beginning at an iron pin on Jones Avenue joint corner of Lots 18 and 19 and running thence with line of Lot 19, *S. 89-08 E. 150 feet* to an iron pin; thence *S. 1-18 W. 65 feet* to corner of Lot 17; thence with line of lot 17, *N. 89-08 W. 150 feet* to Jones Avenue; thence with Jones Avenue, *N. 1-18 E. 65 feet* to the beginning corner. Subject to restrictions set forth in deed of *W. C. McDaniel* to *S. E. Floyd*, recorded in *R. M. C.
