

TITLE TO REAL ESTATE

STATE OF SOUTH CAROLINA

*The American Spinning Company, Inc.*

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, of said County and State, hereinafter called Grantor, for and in consideration of the terms, conditions and privileges hereinafter expressed, and the sum of ONE (\$1.00) DOLLAR to the Grantor in hand paid by *Lester Breunelle* ~~the~~ ~~Grantor~~ ~~and~~ ~~his~~ ~~successors~~ and assigns, the right, privilege and easement to go in and upon that tract or loc of land situate in Greenville Township, in said County and State, and described as follows:

*bounded by land of D. P. Montgomery, Piedmont and Northern Railway Company, the Furman Road, et al. The line beginning at the northern end of the present Trunk line of the American Spinning Company, Inc. and running in a northerly direction on the east side of a track to property of D. P. Montgomery,*

and to construct, maintain in and upon and use in and through said premises, in a proper manner, with necessary apparatus and appliances such as machinery, air vents, manholes, blowoff connections and any and every other necessary and proper attachment, pipe lines, for water and sewerage purposes through the premises above described, together with the right a. all times to enter in and upon said premises for the purpose of inspecting and making necessary repairs and alterations of said line, together with the right to cut away and keep clear of said pipe lines all trees and other obstructions that may in any way endanger the proper operations of same. *herein mentioned*

IT IS UNDERSTOOD AND AGREED: That the easement herein granted shall extend throughout the property of the Grantor about *1939* feet, and shall be of such width as the Grantee shall deem necessary for the purposes herein specified, and that the damage for which said Grantee may be held liable shall be confined to that arising from the use of this strip only, and nothing beyond.

IT IS FURTHER AGREED AND UNDERSTOOD: *That this easement is to be used only during the construction or repair of said pipe lines and with the exception of the right of the Grantee, its successors and assigns, agents, servants, and employees to inspect said pipe lines and to enter at any point and make repairs, the Grantor has the right to cultivate and use the land; provided, however, that this shall not apply to such part wherein the top of the pipe is less than eighteen (18) inches underground.*

IT IS FURTHER AGREED: That, as a part of the consideration hereof, the Grantor herein *and* *his* heirs and assigns of *the same*, may make *taps on* connections with said pipe lines bearing the expense thereof, provided, however, that such connections or taps be made only under the rules and supervision of the engineers representing the Grantee, its successors and assigns.

IT IS FURTHER UNDERSTOOD AND AGREED: That in case of future damage to crops or property due from accident in said pipe lines, the Grantee shall pay reasonable damage therefor. *with the water here will sever District Commission*

The payment and privileges above specified are hereby accepted in full settlement of all claims and damages for said easement.

All other terms and conditions of this Grant of Easement are as follows:

*None which the easement herein described is granted: provided, however, that such connection shall be made only under the supervision and rules of the Engineer representing Lester Breunelle Breunelle District Commission, or their successors, and subject to the rules now or hereafter to be made by said Commission.*
