14. Upon default by the Vendee at any time for more than thirty days in the payment of any instalment required to be paid as provided in paragraph 2 and 6 er in the payment of taxes and assessments against the said real estate, this contract shall automatically become mull and void unless such derault shall be waived in writing by the Vendor, and the Vendor in such event shall be entitled: (1) To immediate possession of the said real estate and (2) to keep and retain as liquidated damages for the failure of the Vendee to comply with the terms of this contract as well as for a reasonable and agreed compensation for the right to the use and enjoyment of said real estate for the period this contract shall have been in force, the aggregate cash payments, including the benefit of all amounts paid on account or taxes and assessments against the said real estate, which at such time shall have been made by the Vendee, without any offset whatsoever, A waiver by the vendor of any one or more defaults hereunder shall in no way be deemed, or estop a denial of, the waiver or subsequent defaults thereafter coouring.
