J. P. Lockhart, his heirs and assigns:

All these two pieces, parcels or lots of land, situate, lying and being in Grassy Mountain Township, State and County aforesaid, and described as follows:

1. Beginning at a stone on corner of the 2.6 acre lot of land this day sold to me by J. P. Lockhart, and running thence N. 55.05 E. 183 feet to a stone; thence S. 1.45 W. 119 feet to a stone by a hickory; thence N. 86.50 W. 155 feet to the beginning corner, containing .21 of an acre. This is a portion of the 28.50 acre tract this day purchased by me from J. P. Lockhart as executor.

2. Beginning at a stone at the corner of the 1.23 acre lot this day purchased from J. P. Lockhart, and running thence N. 47.30 E. 144 feet to an iron pin; thence S. 67.50 E. 1264 feet to a flint rock; thence S. 39.40 W. 136 feet and 4 inches to a flint rock; thence N. 67.50 W. 1264 feet to the beginning corner, containing 3.62 acres, more or less.
