in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant bargain, sell and release unto the said J. H. Rainey, all my right, title and interest of, in and to

all that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, known as the old Campbell place, located about one mile east from the Augusta Road, 4 miles from Piedmont, on branch waters of Grove Creek, bounded on the North by lands of Dr. S. D. Campbell, on the East by lands of D. P. Pearson; on the South by lands of D. P. Pearson and S. A. Mims; on the West by lands of J. L. Campbell, and having the following courses and distances according to survey and plat by W. J. Riddle, surveyor, dated March 21, 1934; Beginning at an iron pin on road; corner of Dunk Pearson land, running thence with Pearson line N. 52-30 E. 1350 ft. to iron pin; thence N. 3-08 W. 2206 ft. to iron pin on branch; thence with the branch the following courses and distances: N. 5- E. 49 ft.; S. 88-45 W. 242 ft. N. 67-45 W. 237 ft.; S. 87- W. 610 ft.; N. 69-30 W. 220 ft. to J. L.
