(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Isadry E. Satterfield, his heirs and assigns:
That certain tract of land in Butler Township, said County and State containing thirty-six acres, and designated as Tract No. 1 on plat of the T. B. Snow Estate, prepared by C. S. Wickman, April 14-1936 and having the following Courses and distances to-wit: Beginning at a stake south of community road leading to Pelham, commencing with lands of R. H. Taylor and of G. W. Smith Estate, and running thence N 27-45 W 1668 feet to stake (stone) just on Little Branch, thence N 52-32 E 625 feet to angle at or near said Branch, thence S 71-40 E 549 feet to iron pin at angle of said Branch, thence S 22-30 E 834 feet to Common 3 X 3 m on northern side of said Community Road; thence, crossing said road, N 70-30 E. 232 feet to iron pin on south side of said Community Road; thence S 40-00 E 657.6 feet to stone; thence N 88-57 W. 913.5 feet to Mulberry Lump; thence S 28-28 W 569 feet to stake the beginning corner. Bounded north-west by lands of J. F. Smith; north by lands of Dick Makaffey; north-east and east by Tract No. 2 on said plat; south by lands of J. E. Lumney and of R. H.
