That certain lot of land near the town of Greer, Slick Springs Township, said County and State, designated as Lot No. 27 on a plat of the W. S. Smith Property, prepared by H. A. Brockman, Surveyor, May 25, 1936, and delineated as follows:

Beginning on Sarey Avenue N. W. corner of lot # 34, and running thence N 1-30 W 165 feet to point on rear line of lot # 35; thence N 67-37 W 113 feet to corner of lot No. 25 on rear line of # 26; thence N 20-44 E 158 feet to Sarey Avenue; thence with and along Sarey Avenue S 69-25 E 57.7 feet to the point of beginning, bounded north by Sarey Avenue; East by Lots Nos. 34-33-32; South by Lots 29-28-26; and West by lot # 25.
