All that piece, parcel or lot of land situate, lying and being in the State and County aforesaid, near the City of Greenville, and being the Eastern portion of Lot No. 22 in a sub-division known as "Cast Ova" and having the following metes and bounds, as per plat made by P. E. Dalton Engineer July 1930, recorded in Plat Book "F" at page 42 in the P.M.G. office for Greenville County:

Beginning at an iron pin on Beechwood Avenue, corner of Lot No. 21 and running thence N. 20-08.215 feet to an iron pin; thence N. 63-0 W. 77.5 feet; thence in a straight line 215 feet, more or less, to Beechwood Avenue; thence with said Beechwood Avenue S. 71-55 E. 115 1/2 feet to the beginning corner.
