to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Wm. V. Schumpert

"All those four certain parcels or lots of land situate in the city of Greenville, County and State aforesaid, fronting on the north side of Chicora Street and the south side of Rhett Street and being known and designated as lots Nos. 49, 50, 60 and 61 of the Thomas M. Walker Company. The property as shown by plat of same recorded in the R. M. C. Office for Greenville County in plat book E. at page 146 and according to said plat more particularly described as follows:

Beginning at a stake on the north side of Chicora Street which stake is 246 feet East of the intersection of Chicora Street and River Street, and running thence along Chicora Street N. 80-15 E. 50 feet to stake at corner of lot #48; thence along line of lots #48 and #62 N. 10-50 W. 188.7 feet to stake on the south side of Rhett Street; thence along Rhett Street S. 71-54 W. 50 feet to stake at corner of lot #59; thence along line of lots #59 and #51 S. 10-42 E. 181.74 feet to the point of beginning on Chicora Street.

The property herein conveyed being a portion of the property conveyed to the within grantor by W. Frank Hupp by deed dated Feb. 16, 1934, recorded in the R. M. C. office for Greenville County in deed book 178 at page 344.
