All that certain piece, parcel or tract of land containing 18.65 acres, more or less, situate on the north side of State Highway No. 251 to the west of the East Fork of Fall Creek Saluda Township, State and County aforesaid, and being more particularly described as follows, according to plan made by H. S. Brocman, Surveyor, September 14, 1937:-

Beginning at a point, center of bridge on East Fork Fall Creek where the same crosses State Highway No. 251, and running thence in a Northwesterly direction to an iron pin on the north side of State Highway No. 251; thence N. 61.15° 24.547 feet to an iron pin in 2d. C. stamp; thence along line of land belonging to Saluda Lumber Company N. 87.00 2d. 140.2 feet to an iron pin on the east side of State Highway No. 251, thence along line of State Highway No. 35 S. 21.45° E. 447.5 feet to an iron pin; thence S. 48.45° E. 200 feet to an iron pin; thence S. 63.45° E. 300 feet to an iron pin; thence S. 54.45° E. 100 feet to an iron pin; thence S. 20.20° E. 100 feet to an iron pin; thence S. 17. E. 75 feet to an iron pin at Saluda sign post (at a point where State Highway No. 251 begins); thence along what is approximately the center of State Highway No. 251 N. 47.6. 136 feet to the center of a bridge over East Fork Fall Creek; thence following approximately the center of State Highway No. 251 N. 55.30 E. 16.2 feet to a point; thence N. 64.15 E. 89.5 feet to a point; thence N. 60.30 E. 190.5 feet to a point; thence N. 71.20 E. 277 feet to a point; thence N. 84 E. 79 feet to the beginning point on bridge.
