to it in hand duly paid at and before the sealing and delivery of these presents by the grantee, hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Charles M. McLean Jr.

All that piece, parcel or tract of land in Chick Springs Township, Greenville County, State of South Carolina, containing 22.90 acres more or less according to a survey of W. J. Riddle made April 1st, 1937 and having the following metes and bounds according to said plat:

Beginning at a stake in road at corner of property conveyed by Cherry Investment Company to Amanda Morris and running thence with Morris line S. 38 W. 1647 feet to stake; thence S. 34-30 W. 381 feet to concrete monument in line of Paris Mountain Water Company; thence with line of Paris Mountain Water Company N. 1-45 E. 1540 feet to iron pin in creek; thence with Creek N. 64 E. 242 feet; thence S. 88-15 E. 97 feet; thence N. 84-30 E. 283 feet to branch; thence N. 78-30 E. 275 feet to stake in road; thence with road S. 71-15 E. 252 feet to bend; thence still with road S. 52-45 E. 81 feet to beginning corner.
