to it in hand duly paid at and before the sealing and delivery of these presents by the grantee, hereinafter named (his receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Charles T. Russell,

all that piece, parcel or lot of land in
Grape & Peppermint T. 10 S. R. 12 E., Greenville County,
State of South Carolina, situated on the
little Texas Road, about ten miles from the
City of Greenville, bounded by lands of Nelcomke
and Stokes, known as tract No. 8 on plat
of Grape & Peppermint Deed of Survey made by
W. J. McElveen, April 1st, 1937, containing 1.77
acres, and being the following corners
and distances according to said plat.

Beginning at an iron rail in center
of road on edge of Wadsworth running
thence east side road N. 15° 2' 20" E. 2982
feet to you; thence S. 52° 45' 6" E. 359 feet
to Nelcomke line; thence east line of
Nelcomke property N. 0° 3' 2" W. 328 feet to first
corner of Stokes property, thence east
line N. 88° 31' 6" E. 94 feet to iron rail

grantee hereinabove named, and
heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
