All that lot of land in Greenville Township, Greenville County, South Carolina, in Ward Three of the City of Greenville, and being more fully described as follows:

Beginning at an iron pin on the south side of West Washington Street 728 1/2 feet west of Westfield Street, and being the corner of the lot formerly owned by Mrs. L. I. Mordeith, and running thence with line of said lot S. 28-15 W. 150 feet to an iron pin; thence in a straight line N. 57-45 W. 50 feet to an iron pin in Dean and Hobbs line; thence N. 28-15 W. 150 feet to an iron pin on south side of West Washington Street; thence with said West Washington Street S. 57-45 W. 50 feet to the beginning corner; being one of the lots conveyed to the grantor herein by George Brownlee by his deed dated July 8th, 1930, and recorded Nov. 0, 1930, in Book 111 page 344.


