petually maintain a pole line with the necessary wires, cross arms, guy wires and other usual fixtures and appurtenances used or adopted  
for the transmission of electric current for light, heat, power or any other purpose, on the said street or highway known as  
or on my land  
described as follows:  
as per above description

Also the right, privilege and authority to cut or trim trees along said line necessary to keep the wires thereof clear at least  
twenty (20) feet.

PROVIDED, however, any damage (other than tree damage) to the property of the undersigned, caused by the said authority in main-  
taining or repairing said electric transmission line, shall be borne by said authority, its successors and assigns.
