All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, and described as follows: in the section known as McCullough Heights, and having the following metes and bounds, to-wit:

Beginning at an iron pin, on corner of Lots Nos. 19 and 20, on Donnybrook Street, and runs thence with the line of Lots Nos. 19 and 20, 126 feet to a stake on an alley, thence with the line of the said alley and parallel with Donnybrook Street 75 feet to a stake in the line of Lots Nos. 18 and 19, thence with the line of Lots Nos. 18 and 19 to an iron pin on Donnybrook Street; thence with the property line of Donnybrook Street, to the beginning corner and being a portion of Lot No. 19 on a subdivision more fully set forth in a plat recorded in Plat Book E, page 95, and known as McCullough Heights, said plat being hereby referred to for a more complete description and is made a part of this conveyance.

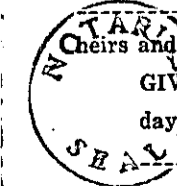
