TITLE TO REALESTATE

## EXCHANGE PLANT PERMIT

Received of the Southern Bell Telephone and Telegraph Company, One Dollar (\$1.00) in consideration of which we hereby grant unto said Company, its associated and allied companies, -their respective successors and assigns, a right of way upon, across, over and/or under the property hereinafter described, in the manner and at the location and specifie points hereinafter described, the right, privilege and authority to construct, operate and maintain its lines of telephone and telegraph, and for the general transmission of intelligence, including the necessary underground and aerial cable, conduit, poles, wires, guys, anchors and other fixtures appurtenance as the grantee may from time to time require; and the right to permit the attachment of the wires of any other company, or person, to said poles and fixtures, together with the right to trim and cut down trees and other obstructions so as to Clear and keep cleared said Company's plant.

The following is a description of the property which said poles, cables, wires and fixtures shall be constructed and maintained;

"All that certain lot (or lots ) of land in and near the City of Greenville, County of Greenville, and State of South Carolina, and being known as Forest Hills and Addition No. 1 to Forest Hills, Plats of said property being recorded in Plat Book D, at pages 206 and 226 in office of Register of Mesne Conveyance, of Greenville County, South Carolina.

The following is a description of the location and the manner in which said poles, cables, wires and fixtures are to be constructed and maintained;

FOREST HILLS

BLOCK A.

Bounded by Pine Forest Drive, McIver and Cleveland Streets,

Line to be constructed aerially in alley at rear of lots numbers 1 to 7 inclusive and 20 t to 30 inclusive, thence along the rear property line of lots numbers 8 to 19 inclusive, thence along the North property line of lot Number 20 and the West property line of lot number 14.

BLOCK B.

Bounded by Pine Forest Drive, McIver and Cleveland Streets.

Line to be constructed aerially along the rear property line of lots numbers 1 to 47 inclusive, thence along the East and South property lines of un-numbered lot fronting approximately 2h feet on Cleveland Street, and along the North property line of lot number 20.

"BLOCK C.

Bounded by Cresent Avenue and Pine Forest Drive.

Line to be constructed aerially along the rear property line of lots numbers 1 to 41 inclusive, thence along the West property line of lots numbers 1 and 41. "

ADDITION MO. L TO FOREST HILLS

BLOCK

Bounded by Cresent Avenue and Lannaeu Drive.

Line to be constructed aerially along the West property line of lot number 1 from Cresent Avenue Southwardly, a distance of approximately 150 feet, thence East across said lot number 1 and lots numbers 2, 3 and 4, also beginning at a point along the West property line of lot number 1 and approximately 150 feet from Cresent Avenue line to be constructed Southwardly along the West property line of lot number 1 to rear of lot number 6, thence along the rear property line of lots numbers 6 to 10 inclusive.

While the lines are intended to run along the property lines of the above mentioned lots, the right is granted for the cables, wires, etc on curves and turns to overhang the rear or side property lines as necessary.

The Company agrees to re-locate at its own expense, on said property, its lines and fixtures to conform with future building improvements.
