## EXCHANGE PERMIT.

Received of the Southern Bell Telephone and Telegraph Company, Fifty Dollars in consideration of which we hereby grant unto said Company, its associated and allied companies, their respective successors and assigns, the right, privilege and authority to construct, operate and maintain one vourse or line of telephone and telegraph poles, including the necessary wires, cables and fixtures thereon, and in addition thereto the further right to erect and set the necessary guys and anchors, and to attach thereto the necessary guy wires, incident to the erection, operation and maintenance of said poleline upon, across, over and/or under the property which we own, located Southwest of Greenville, S. C., on the Easley Bridge road, in the County of Greenville and State of South Carolina, upon the following conditions to wit.
