WHEREAS, it appears that The Norwood National Bank of Greenville has never transferr ed and conveyed the lots hereafter described to The South Carolina National Bank of Charleston, but That The South Carolina National Bank of Charleston has by its deed which is recorded in the R.M. C. Office for Greenville County in Deeds Vol. 172 at page 209, attempted to convey the said lot to ed, and

WHEREAS, the said A. F. Balentine has since conveyed the said lot to Vincent A. Pruitt by deed recorded in the R. M. C. Office for Greenville County, S.C. in Deeds Vol. 193, at page 36;

NOW, THEREFORE, this conveyance is made by The Norwood National Bank of Greenville, as Trustee, under and by virtue of the power and outhority vested in it as Trustee by the said deed of all title and right to said property, and this said deed is made with the assent of Realty Corporation, NOW

KNOW ALL MEN BY THESE PRESENTS, That The NorwoodNational Bank of Greenville, as Trustee, a corporation created under the banking laws of the United States of America, and having its principal place of business at Greenville in the State of South Carolina, for and in consideration of the sum of One and OO/100 (\$1.00) Dollar and the premises to it in hand duly paid at and before theseal-acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Vincent A. Pruitt, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, South Carolina, on the South side of Mountivista Avenue, known and designated as Lot No. 188 on Plate of Traxler Park, made by R.E. Dalton, March, 1923, andhaving, according to said plat which is recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book F, pages 114-117, the following metes and bounds, to wit:-
