KNOW ALL MEN BY THESE PRESENTS, That I, Hext M. Perry, Trustee, of the County of Greenville,

in the State aforesaid in consideration of the sum of one hundred and fifty (\$150.00)

to me in hand paid, at and before the sealing of these presents by R. L. Ellison

the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said R. L. Ellison.

All that certain piece, parcel or lot of land situate and being on McMakin Drive, known and designated as lot numbered sixty (60), on plat of said property recorded in the R. M. C. Office for Greenville County in Plat Book "I" at page 32, said lot being in that section known as Sans Souci near the New Buncombe Road about three miles north of the City of Greenville, and having the following lines, courses and distances, to-wit:-

Beginning at an iron pin on a five foot sidewalk two hundred and fifty feet from an iron pin on the eastern edge of a six foot sidewalk running along King Street at its intersection with McMakin Drive, the joint corner of lots numbered sixty and sixty-one; thence along said sidewalk running along McMakin Drive N. 79-28 E. fifty (50) feet, to an iron pin; thence S. 10-17 E. one hundred and fifty (150) feet, to an iron pin; thence S. 79-28 W. fifty (50) feet, to an iron pin, joint rear corner of lots numbered sixty (60) and sixty-one (61); thence with the line of lot numbered sixty-one (61), N. 10-17 W. one hundred and fifty (150) feet to an iron pin, the beginning corner, the same being designated as lot numbered sixty (60) on Plat of said property recorded in Plat Book "I" at page 32, in the Office of the R. M. C. for Greenville County, which plat is hereby referred to and made a part of this deed.

Said property is sold subject to the following restrictions, which constitute a part of the consideration therefor, and shall be effective for a period of twenty-five (25) years from the date of this deed:- 1. Said property is to be used for residential purposes only.

2. No house is to be erected on said lot nearer the sidewalk running along McMakin Drive than twenty (20) feet.

3. No residence is to be erected thereon at a cost of less than two thousand dollars (\$2,000.00).

4. The property is not to be sold to any person of African descent.

AND I do hereby bind myself, my successors, heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said R. L. Ellison, his heirs and assigns,

against me and my successors heirs, and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.
