All that certain piece, parcel or tract of land, situate, lying and being in Gantt Township, Greenville County, State of South Carolina, known and designated as a portion of tract #9, according to a plat of the property of Greenville Realty & Investment Co., made by R. E. Dalton, Engineer, December, 1923, and having the following metes and bounds:

Beginning at a point in the center of a 16 ft. road at the southeast corner of the tract heretofore conveyed to W. J. Hendrix and running thence with Hendrix line N. 2-51 W. 862 ft. to iron pin; thence N. 83 E. 198 ft. with line of Burns property to iron pin; thence S. 52-58 E. 852.3 ft. to iron pin in center of said 16 ft. road; thence with center of said road S. 80-45 W. 200 ft. to the beginning corner.
