Beginning at an iron pin on the east side of Lindberg Street 254.7 feet S. 7-21 E. from the center line of Edison Street, and running thence N. 82-39 E. 125 feet to an iron pin; thence S. 7-21 E. 80 feet to an iron pin; thence S. 82-39 W. 125 feet to an iron pin on Lindberg Street; thence with Lindberg Street N. 7-21 W. 80 feet to the beginning corner.
