INMAN, Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree., and partion of properties between Plaintiffs and Defendants HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Mary Louise Bannon, for and during the term of her natural life and at her death to James Gallivan Bannon, his heirs and assigns forever, the following described property, to-wit: "All that certain piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the South side of West Washington Street, and having the following metes and bounds, to-wit: Beginning at an iron pin on said Washington Street, corner of lot formerly belonging to W. C. McKenzie, and running thence $^{\rm N}$. 50 feet with Washington Street to an iron pin on line of Mrs. Julia E. Shummate; thence W. 1672 feet to a line on lot formerly owned by Mary A. Stewart; thence S. 50 feet to a line on lot formerly owned by W. C. McKenzie; thence with said line 1672 feet to the beginning corner, and being the same lot of land conveyed to Hattie B. Stover by W. T. Bull. And being the same conveyed to James F. Gallivan by E. Inman, Master, for Greenville County, by deed dated May 20, 1922, and recorded in the R. M. C.
