TITLE TO REAL ESTATE

To Have and to hold the said premises unto the said Joseph E. Brunson, lessee, his executors, administrators and assigns for the said term.

It is agreed by the parties hereto that this lease shall continue from year to year on the same terms for four additional years at the option of the lessee, unless the lessee desiring to terminate this lease at anytime after May the first, 1942, shall give the lessor notice in writing sixty days before the time of such desired termination.

It is further agreed by the parties hereto that destruction of the premises by fire, storm or other casualty; or failure of the lessee to pay the monthly rental within fixty days after said rental is due, shall terminate this lease.

It is further agreed by the parties hereto that lessee shall have the free use of the ground now vacant around the said residence and the sole right to the use of both wells on the property and shall provide a water spigot at a convenient place in the yard for the use family tenants in adjacent buildings as they now are.

It is further agreed by the parties hereto that the lessee shall have the right to remove the water pumps, piping, plumbing fixtures, lighting fixtures and such other aparatus as he may place on the premises at his own expense, subject to the payment of any unpaid rents.

It is further agreed by the parties hereto that the lessor shall keep the roof, foundations and other structural features of the building in good repair at his can expense, and that the lessee shall have the right to make any changes in arrangement which he may wish to make at his own expense.
