in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Crescent Realty Company, a corporation, all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

being known and designated as Lot No. 16 according to Plat of property of T. Q. Donaldson Estate, which Plat is recorded in Plat Book H, page 284, R. M. C. Office for Greenville County, and being more particularly described as follows:

Beginning at an iron pin on the North side of Camille Avenue, corner of Lot No. 17, and running thence N. 5-09 E. 160 feet to iron pin in rear line of Lots Nos. 17, 30 and 38; thence with Lot No. 30, S. 04-51 E. 71 feet to iron pin in line of Lots Nos. 15, 27 and 30; thence with Lot No. 15, S. 5-09 W. 160 feet to iron pin on North side of said Avenue; thence with said Avenue N. 04-51 W. 71 feet to the beginning.

The following restrictions shall be imposed against said lot, but a violation thereof shall not be construed to constitute a forfeiture, and said restrictions are imposed for the benefit of all lot owners in this subdivision:

1. The above lot shall be used only for residential purposes.
2. No dwelling shall be erected on said lot nearer than 30 feet to Camille Avenue.
3. No dwelling shall be erected on said lot costing less than \$3500.00.
4. The above property shall not be leased, rented, sold or otherwise disposed of to persons of African descent.

And I do hereby bind myself, my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Crescent Realty Company, a corporation, its successors,

and assigns, against me and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.
