All those lots of land situate in the State of South Carolina, County of Greenville, near the Town of Marietta and designated as Lots Nos. 65 and 66 on Midway Drive according to a plat of the property of J. Norwood Cleveland and estate of R. Mays Cleveland made by W. M. Rast, Engineer, in June, 1927, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at a point on Midway Drive 100 feet northwest from the corner of Midway Drive and East Avenue joint corner of Lots 66 and 67 and running thence with the joint line of said lots 150 feet to a point in the rear line of said lots; thence N. 63°47' W. 50 feet to joint corner of Lots 64 and 65; thence with the joint line of Lot 64 and 65, 150 feet to a point in Midway Drive; thence S. 63°47' E. 50 feet to the beginning corner.
