All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, situate, lying and being on the East side of the Anderson Road, and being more particularly described as follows:

Beginning on the east side of the Anderson Road, corner of property of grantor and grantee; thence along said line and property of H. W. Bellick S. 22-25 E. 652 feet, more or less, to an iron pin, which is joint corner with Bellick; thence along a new line N. 50-5/8 E. 565 feet to iron pin (new corner); thence continuing with grantor's line N. 53-1/8 W. 647 feet to iron pin (new corner); thence along the bank of the Anderson Road 230 feet to the beginning.
